Letter to Request Continuation of Special Education Services or Request an Initial Evaluation in New York State

Eligibility

- 1) A homeschooled student must be entitled to attend the public school without payment of tuition pursuant to Education Law § 3202(1),
- 2) The student must have an individualized home instruction plan (IHIP) filed with their district of residence that has been determined to be in compliance with section 100.10 of the Regulations of the Commissioner of Education,
- 3) Parent must request special education services in writing to the board of education of the school district of residence:
 - By June 1 preceding the school year for which the request for services is made.
 - For a student who is first identified as a student with a disability after the first day of June preceding the school year for which the request is made and prior to the first day of April of such current school year, the parent must submit the written request for services within 30 days after the student was first identified.
 - A request may also be submitted within 30 days of a change in the student's school district of residence.

Additional helpful information

- Special education service must be provide to homeschooled student on an equitable basis as compared to special education programs and services provided to other students with disabilities attending public or nonpublic schools within the district.
- Parents of homeschooled students who disagree with the IESP recommendation of the CSE would be entitled to due process pursuant to Education Law section 4404 just as parents of nonpublic students are.
- The local board of education determines the location where special education services will be available to homeschooled students, which <u>could</u> include the site of the home school.
